Susan is a Level IV National Examiner for USPC (thru "A" level for specialty rating in dressage and traditional eventing A), a USEA ICP Level III (thru Intermediate eventing) Instructor and a USDF certified instructor through 4th Level. Susan L. Harris has been teaching riding lessons since the early 1970s. She is an "A" level graduate of USPC. She has achieved her silver medal through the USDF and grew up competing in the hunter ring and fox hunting with Long Run Hounds. This clinic is offered to Midsouth Pony Club members rated at D3 and above (flat/Dressage). Members who have not yet reached that level and are interested in riding in the clinic should first contact clinic organizers. This year, we have also opened up our regional clinics to non-PC member adult riders.

The clinic fee is \$55 per 40 minute individual ride. The clinic will be held at Meadow Lake Equestrian Center in Lancaster, KY (25 miles south of Lexington). Stabling is available onsite for an additional \$25/night and includes initial shavings (additional can be purchased onsite). Floors are dirt/mats & stabling facilities are excellent.

Members are permitted to ride more than one horse/day but each horse should be limited to one 40 minute ride/day. If we have more entrants than can be scheduled, we will create a wait list. To get the most of the clinic, both horse and rider should be fit enough to ride the entire 40 minutes. The indoor arena has been reserved in the event of rain or extreme August heat.

Clinic scheduling limits the clinic to 14 rides/day (830am-650pm) and will be filled based on order received. A wait list will be created for members entered after the 14 ride/day limit and for non-pony club adult riders. If the clinic is not yet full on the closing date, the wait listed adult riders will be admitted into the clinic.

Entry status and clinic ride times will be posted on the REGIONAL CLINICS page of the www.midsouthponyclub.org web site. No checks will be deposited before the closing date and then only deposited if you were accepted into the clinic. Email is the preferred method of communication – include member name and pony club in all of your email communications.

Please remember a veterinarian's health certificate within 30 days is required for horses traveling into Kentucky.

Stabling at Meadow Lake Equestrian Center: 20 permanent stalls with doors for \$25/night per stall. Initial bedding is provided.

From Lexington: From KY-4, take exit 19 for US 27/Nicholasville Rd. Keep right at fork & follow signs **towards** Nicholasville Rd/US-27 (total 20 miles on US27) Meadow Lake will be on your right. **From** Nicholasville, entrance is on left.
